Training

Training will occur on Saturdays from 9 am until 12. These hours will be extended as the club grows.

30-minute bookings are to be made via the online calendar, and these will be shared between three people/dogs. This will allow each dog to have a short break in between periods of activity e.g. 5 mins on, 5 mins off etc.

If you have other commitments, it may be possible to ring-fence a particular time. Please let us know when completing the membership signup.

Cancellations

Cancellation can be made at any point. Please email flyball@dogsinaction.club to let us know that you would like to cancel your membership.

Refunds

Refunds are not available. For example, if you have paid your monthly subs, but decide to cancel after the first week, you will not be refunded for the following three sessions.

Competitions

In due course, we will be grouping club members into Teams. Considerations for this will be individual availability, appetite for competing, and how specific dogs get on with each other.

Team training sessions may take the place of individual training sessions.

Weather

Training may be cancelled owing to inclement weather.

Winter is a particularly difficult time when the ground becomes unsafe for the dogs.

Training sessions will be adapted to cater for this.

Training Cancellations

At present, Jonathan and Lucy are the only trainers at the club. On occasion, training may be cancelled owing to personal circumstances. Unfortunately, we do not provide refunds as the ongoing ground rent and insurance charges prevent this.
